**Order of Judging:**

Non-Regular Classes Puppy 3-6 mos. & Spay/Neuter

Followed by: Junior Showmanship

Followed by: Regular Conformation - Dogs, Bitches

All non-regular & regular classes judged by Mr. William Sahloff, AKC

**Fees:** Regular Classes \$20; Non-Reg. Classes \$15  
Junior Showmanship free if dog is entered in a regular class  
**All dogs entered must be LCA or FSS registered**

**Class Descriptions - Classes apply for both dogs and bitches:**

**Non-Regular Conformation**

- Best Baby Puppy 3-6 mos.
- Best Spay or Neuter

**Junior Showmanship - Junior, Intermediate and Senior Classes**

- Junior Class - Boys and girls who are at least 9 years old and under 12 years old on the day of the show.
- Intermediate Class - Boys and girls who are at least 12 years old and under 15 years old on the day of the show.
- Senior Class - Boys and girls who are at least 15 years old and under 18 years old on the day of the show.

**Regular Conformation Youth Classes**

- Youth Dogs/Bitches 6-9 months on day of show
- Youth Dogs/Bitches 9-12 months of age on day of show.
- Youth Dogs/Bitches 12-18 mos. on day of show.

**Regular Conformation Adult Classes ( non-champions over 18 mos.):**

- Novice Dogs/Bitches - Has not won 3 Novice first place or 1 first place in any other adult class.
- Bred By Exhibitor - Dogs/Bitches exhibited only by their owner-breeder.
- Foreign Bred Dogs/Bitches -- Born outside the United States
- Open Dogs/Bitches

**Special Adult Classes listed below do not compete for LCA Ch. Points. 1st place winner(s) compete for Best of Breed and Top Leo points:**

- Veteran Dog/Bitch-7 yrs., inc. LCA Champions, intact or produced litter.
- LCA Champion Dog/Bitch
- The Best Youth Male/Female will compete with the first place adult winners for Winners Dog/Bitch.

Trophies and rosettes shall be presented for:

Best of Breed - Best of Opposite Sex - Best of Winners

Ribbons will be presented for first thru fourth class placements.

Special awards will be given to non-regular & Jr. Showmanship winners.

**All dogs must be on leash or crated. The club reserves the right to excuse any dog from the show that is out of control or exhibits aggression to any dog or person.**
