Class Descriptions - applies for dogs and bitches

All ages apply on the day of show

Non Regular Conformation

- Best Baby Puppy 3-6 months
- Best Spay or Neuter

Junior Showmanship – Junior, Intermediate and Senior Classes

- Junior – boys and girls who are at least 9 years old and under 12 years old
- Intermediate – Boys and girls who are at least 12 years old and under 15 years old
- Senior – Boys and girls who are at least 15 years old and under 18 years old

Regular Conformation

Youth Classes

- Youth dogs/bitches 6-9 months
- Youth dogs/bitches 9-12 months
- Youth dogs/bitches 12-18 months

Adult Classes (non-champion over 18 months)

- Novice Dogs/Bitches
 - Has not won 3 Novice first places or first place in any other adult class
- Bred by Exhibitor
 - Dogs/bitches exhibited only by their owner-breeder
- Foreign Bred Dogs/Bitches
 - Dogs/bitches born outside the United States
- Open Dogs/Bitches

Special Adult Classes

- Veteran Dogs/Bitches
 - Dogs/bitches 7 years old or older, including Champions and dogs/bitches which are either intact or have produced a litter
- Champion Dogs/Bitches – Limited to LCA champions
- Best Youth Dog and Bitch
 - Will compete with first place in the adult classes for Winners Dog/Bitch

Directions

To Show Site: AADTC ~ 1575 E. North Territorial Road Whitmore Lake, MI 48189

From the East: Take exit 1 to merge onto I-275 S/I-96 E toward Toledo Continue to follow I-275 S, Take the exit onto M-14 W toward Ann Arbor, Merge onto US-23 N, Take exit 49 for N Territorial Rd, Turn right at E North Territorial Rd Destination will be on the left

From the West: Merge onto I-94 E via the ramp to Detroit, Slight left at M-14 E (signs for Plymouth), Continue onto US-23 BUS N, Take the exit on the left onto US-23 N toward Brighton/Flint, Take exit 49 for N Territorial Rd, Turn right at E North Territorial Rd Destination will be on the left

From the South: Merge onto I-75 N via the ramp to Detroit, Take exit 204 on the left to merge onto I-475 W toward US-23/Sylvania/Ann Arbor, Take exit 14 to merge onto US-23 N toward Sylvania/Ann Arbor Entering Michigan, Continue onto I-94 BUS N, Continue onto US-23 N, Take exit 49 for N Territorial Rd, Turn right at E North Territorial Rd Destination will be on the left

From the North: US-23 S, Take exit 49 for N Territorial Rd, Turn left at N Territorial Rd W, Continue onto E North Territorial Rd Destination will be on the left

To Cider Mill: Dexter Cider Mill ~ 3685 Central Street, Dexter, MI

From the East: take 94 West to the Baker Road exit, turn right, go to Main Street/Dexter Ann Arbor road, turn left. Take the 1st right (Central Street) we are located about a 1 mile down, over the railroad tracks on the left.

From the West: take 94 East to the Baker Road Exit, turn left off the exit, go to Main Street/Dexter Ann Arbor road, turn left. Take the 1st right (Central Street) we are located about a 1 mile down, over the railroad tracks on the left.

From the South: 23 North to 94 West to the Baker Road Exit, turn right off the exit, go to Main Street/Dexter Ann Arbor road, turn left. Take the 1st right (Central Street) we are located about a 1 mile down, over the railroad tracks on the left.

From the North: 23 South to the N. Territorial exit, turn right off the exit. Go to Mast Road and turn left, 3-4 miles down on the right hand side.
